**TAKE NOTICE** that a decision has been made by the Committee of Adjustment, for a minor variance application **Stephen Lau, Owner**, for relief from the provisions of the Town's Fence By-law 052-05, pursuant to Section 45 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.


The subject property is described legally as **CON 6 PT LOT 26**, is known municipally as **1562 Houston Ave** and is zoned as "**Residential (R1)**".

**The applicant has constructed a fence/partition with a height of 2.24 m. The applicant is seeking relief from section 3.2 of the fence by-law (by-law # 052-05) which allows for a maximum fence height of 0.9 m for fences located withing 6.1 m of the front lot line of residential zones.**

The Committee of Adjustment has considered all written and oral submissions received before and/or during the hearing as part of their decision.


- The Committee **APPROVED** the application and is satisfied that it is in keeping with Section 45 of the Planning Act, is desirable for the appropriate use of the subject property, is minor in nature, and that the intent and purpose of the Official Plan and Zoning By-law have been maintained.

- The Committee **REFUSED** the application and is of the opinion the application is not in keeping with Section 45 of the Planning Act and that the intent and purpose of the Official Plan and Zoning By-law have not been maintained. - The Committee **DEFERRED** the application.
